From the Health Sciences Library: Sharing Data through the Pitt Data Catalog

Do you have data that you would be willing to share with qualified colleagues, but aren't ready to go into a public repository? Do you have datasets in a repository and want more people to find your research? If so, you may want to include your dataset in the Pitt Data Catalog, a new platform from the Health Sciences Library System for sharing and discovering datasets created at the University of Pittsburgh. Just like a library catalog, the Pitt Data Catalog describes datasets and provides access instructions, but does not host the datasets themselves—so you, the researcher, maintain final control over your data.

The NIH now requires a written plan for compliance with the NIH [Policy](#) on the Dissemination of NIH-Funded Clinical Trial Information in all applications for clinical trial funding. NIH Releases Strategic Plan for Data Science

On June 5, 2018, the NIH released its first [Strategic Plan for Data Science](#) to capitalize on the opportunities presented by advances in data science. The plan describes NIH's overarching goals, strategic objectives, and implementation tactics for promoting the modernization of the NIH-funded biomedical data science ecosystem.

The NIH plans to implement this strategy over the course of the next year and will continue to seek community input during the implementation phase.

NIH Announces Stipend and Benefit Increases for National Research Service Award (NRSA) Recipients

NIH NRSA stipends are being increased by two percent for undergraduate, predoctoral, and postdoctoral trainees and fellows for NRSA awards made on or after October 1, 2017.
